to foster the transfer and sustainable integration of the results and outcomes of the core JAPreventNCD work packages five to ten into national and European policies.



- **Collect sustainability elements** of the JA policies and activities and thus **inform and raise awareness of decision makers** at regional, national and EU levels **on integrated and sustainable approaches to improve health determinants and healthy lifestyle** of European citizen
- **Identify windows of opportunity** within **EU governance mechanisms** for facilitating the sustainability of JA integrated interventions after JA ends
- **Enable sustainability of the actions on cancer** in EU by establishment of the **EU Consortium on Cancer Prevention**
- **Foster the transfer and sustainable integration of the results and outcomes recommendations** of the core WPs into regional, national and European policies
- **Foster synergies with JACARDI** with the aim for **higher level of sustainability of actions** of both joint actions while sharing approaches, knowledge and experiences
- **Foster sustainable integration of best practices results** and recommendations into EU and national systems, aligned with the principles of wellbeing economy

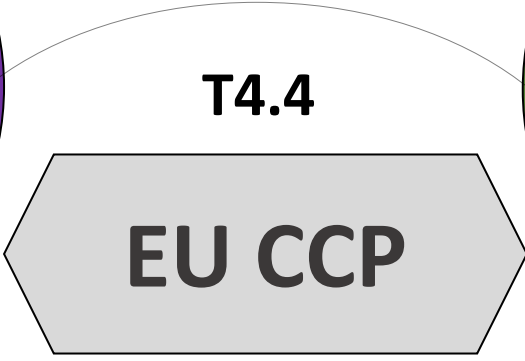
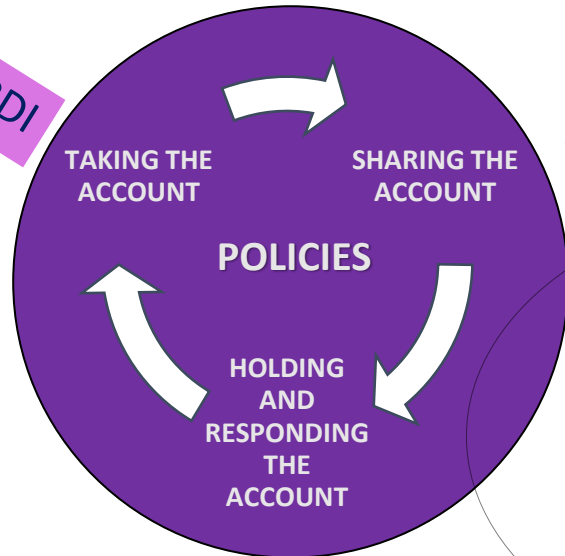

Accountability cycle

Accountability Framework by Kraak et al. 2014

1. TAKE the account – Assessment

- Aim to measure the situation and progress towards targets
 - **Subtask** will follow up the work of WPs 5-10 by searching and exploring the potential of sustainability elements in JA policies/ practices

2. SHARE the account - Communication

- Aim to communicate the results to decision-makers and other actors; in other words, translating information from monitoring into accessible – and compelling – evidence for action
 - **Subtask** will leverage the PDMF, members of the EU-CCP as well as other key experts identified in WP4 to communicate best practices from pilots and related sustainability actions

3. HOLD to account – Enforcement

- Aim to provide appropriate incentives and disincentives to drive desired actions from each set of stakeholders – *the most challenging step of Accountability cycle*
 - **Subtask** will focus on identifying the implementation roles of actors at EU and national levels

4. RESPOND to the account – Improvement

- Aim to take actions to improve specific areas, environments and/or domains.

European Consortium on Cancer Prevention - EU CCP



JA PreventNCD

- Main goals of EU-CCP:
 1. Build a momentum on cancer prevention and health promotion at EU level around a common agenda
 2. Strengthen and expand evidence-based prevention culture
 3. Strengthen advocacy
 4. Combat lobbies and misinformation and disinformation;
 5. Help to deploy validated disease prevention and health promotion interventions at EU level
- Four key annual EU-CCP events: Brussels (2024), Poland (PRED 2025), Ljubljana (2026), Brussels (2027)
- Sustainability elements to allow the Consortium to function in the next decade will be explored and **recommended as the priority**
- What about the EU-CCP? Potential for Sustainability
 - **The EU CCP is a potential form of guarantee for the accountability cycle**
 - The body could act as a forum to foster collaboration, knowledge sharing and implementation across member states (*both sharing and holding to account*)
 - The body's potential lies in ensuring that advances in one country can be translated and applied across the EU, addressing institutional weaknesses in governance and financing
